

SUMMARY

According to the Temporary procedures for control over movements of individuals, vehicles and goods along the contact line in Donetsk and Luhansk regions, entry to the uncontrolled territory and exit from it by citizens of Ukraine and foreigners (stateless persons) shall be permitted on presentation of Ids and permission.

The Coordination Center at the ATO Headquarters organizes the activity of Coordination Groups and conducts awareness-raising work with the population by hot-line phones.

List of entry-exit checkpoints for automobile transport

- 1) road corridor ‘Stakhanov-Zolote-Hirske-Lysychansk’ – checkpoint ‘Lysychansk’;
- 2) road corridor ‘Horlivka-Artemivsk’ – checkpoint ‘Zaitseve’;
- 3) road corridor ‘Donetsk-Kurakhove’ – checkpoints ‘Kurakhove’ and ‘Heorhiivka’;
- 4) road corridor ‘Donetsk-Mariupol (across Volnovakha)’ – checkpoint ‘Buhas’;
- 5) road corridor ‘Novoazovsk-Krasnoarmiisk-Talakivka-Mariupol’ – checkpoint ‘Hnutove’;
- 6) road corridor ‘Stanytsia Luhanska-Shchastia-Novoidar’ – checkpoint ‘Novoidar’.

List of entry-exit checkpoints for railway transport

- 1) on the line ‘Rodakovo’ – ‘Krasnyi Lyman’, Donetsk railways, station ‘Krasnyi Lyman’

(beyond the entry-exit checkpoint the border checkpoint is deployed at the railway station ‘Nyrkove’);

- 2) on the line ‘Yasynuvata’ - ‘Krasnyi Lyman’, Donetsk railways, station ‘Kostiantynivka’

(beyond the entry-exit checkpoint the border checkpoint is deployed at the railway station 'Kryvyi Torets');

3) on the line 'Rodakovo'-'Svitlanovo'-'Lysychansk', Donetsk railways, station 'Pereizna';

4) on the line 'Donetsk'-'Volnovakha', Donetsk railways, station 'Volnovakha'.

5) route "Debaltseve" - "Mykytivka" - "Maiorske" - "Artemivsk 2" - "Krasnyi Lyman", deploying at the controlling the border 'Artemivsk 2';

6) route "Rodakovo" - "Luhansk" - "Kondrashevsk" - "Kondrashevsk -New" - "Gorodnii" deploying at the checkpoint entry - exit "Gorodnii."

The Temporary Order further requires that all persons and transport vehicles entering or leaving the ATO zone possess a special government-issued permit. Permits should be issued within the established deadline of 10 days after the application has been received.

Thereafter, the permit can be collected at the closest checkpoint to the contact line or distrikt police station within government controlled territory, namely in Artemivsk, Starobilisk, Velyka Novosilka and Mariupol. Single or multiple entry permits may be issued

and an application must specify the precise itinerary and period of time to be covered by the permit. The Temporary Order provides that permits may be issued in the following cases: to allow visits of close relatives or family members, including for reasons related to a death in the family; to access a place of burial or personal property; and to safeguard national interests of Ukraine or for humanitarian purposes, for international organisations to carry out their diplomatic or consular functions
